When you donate goods to us we act as your agent selling the goods on your behalf, we can then claim Gift Aid on the proceeds of the sales. If the cumulative net sale proceeds of you goods exceed £100 in any tax year we will notify you in writing. Once notified you then have 21 days to contact YKATW should you wish to collect the proceeds are less than £100 in any tax year we will claim Gift Aid on the proceeds of your goods without notifying you first.

YKATW will not charge commission on the sale of your goods and may dispose of goods that do not sell.
